Notice was given and a Virtual Public Hearing was held on **Wednesday, March 17, 2021**, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

To alter the existing two-storey detached dwelling by constructing a third storey, a rear third storey addition with a rear balcony, a rear second-storey addition with a rear balcony, a rear first-storey addition, a rear ground floor deck, a rear basement walkout, and adding a secondary suite.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

- 1. Chapter 10.5.100.1.(1)(A), By-law 569-2013**
The minimum required driveway width is 2.0 m.
In this case, the driveway width will be 1.44 m.
- 2. Chapter 10.10.40.40.(1)(A), By-law 569-2013**
The maximum permitted floor space index of a detached dwelling is 0.6 times the area of the lot (230.01 m²).
The altered detached dwelling will have a floor space index equal to 0.75 times the area of the lot (289.14 m²).
- 3. Chapter 10.10.40.70.(1), By-law 569-2013**
The minimum required front yard setback is 6.0 m.
The altered detached dwelling will be located 0.3 m from the front (east) lot line.

4. Chapter 10.10.40.70.(3)(B)(i), By-law 569-2013

The minimum required side yard setback is 1.2 m.

The altered detached dwelling will be located 0.59 m from the north side lot line.

The Committee of Adjustment considered the written submissions relating to the application made to the Committee before its decision and oral submissions relating to the application made at the hearing. In so doing, **IT WAS THE DECISION OF THE COMMITTEE OF ADJUSTMENT THAT:**

- The general intent and purpose of the Official Plan is maintained.
- The general intent and purpose of the Zoning By-law is maintained.

- In the opinion of the Committee, the variance(s) is minor.

The decision is subject to the following condition(s):

The rear second and third floor balconies shall be constructed with opaque privacy screening or fencing that is permanent, located on the north, south and west edges of the balconies to a minimum height of 1.5 m, measured from the floor of the balconies.
